Committee has been working on two fronts:

- With the Area 20 DCM, Justin, to facilitate the use of the accessibility survey previously distributed when WAGSA representatives visit various home groups because only about 50 groups in the entire Washington DC extended area completed the survey. When they visit a meeting within a district, at the same time they can complete the accessibility survey. The Accessibility Committee can then double check the information regarding accessibility and cross check it against the information reported in the Where and When meeting list.
- Submitted a budget request to the Washington Area Intergroup Association (WAIA) for funds (\$2500) for American Sign Language (ASL) interpreters in the 2020 budget. Participated in the finance committee meeting for budget preparation. Reached out to area ASL interpreters and the Deaf Accessibility Committee (DAC) in Austin Texas (now the Deaf Intergroup of Central Texas) for support in creating a plan to support the deaf community. The WAIA Executive Committee will review the request at this month's meeting. The request will go to the full board next month.
