- **4. Old Timers Meeting** [Rachel W. & Suzanna D. <u>oldtimers@aa-dc.org</u>] WAIA Old Timers meeting was Friday, November 6th. The purposes of this event are to celebrate our Old Timers and bring in contributions that support the WAIA Hospitals & Institutions Committee.
- This year, we brought in \$967 to support H&I. By comparison, last year's total was \$887.
- Participation-We had around 200 people in attendance this year, which is lower than previous years but likely due to the online format (if anyone got the peak count please share).
- Speakers-We had two panels of 9 speakers, so +/- 18 speakers for three minutes each. The person with the most continuous sobriety had 52 years, and someone with 38 years brought up the lead. We were also privileged to have two members of the WAIA service structure in the panel. Newest person had 17 days.
- Sobriety tally-In the room we counted 2,501 years; 10 months; 1 days. And we pulled off a sobriety tally virtually.

  - 2021 budget feedback and vote-The Finance committee has not received any feedback on the 2021 budget outside of the WAIA board meetings. After our last meeting the Finance Committee adjusted the budget, see the new document <a href="here">here</a>. Using the mid-range Scenario 2, we increased the salary line based on the salary comparisons; scenario assumes some cuts while maintaining the new spend for PSAs and H&I. We propose a pull of about \$13k from the prudent reserve but our current bank and money market funds are at \$190k.
