- We had a successful gratitude month with over \$17,000 in contributions.
- Contributions are over the 2020 projections by \$5,798. This does mean that we will not likely see the big December or January bumps we get from gratitude donations rolling in, but the monthly increases in regular individual donations have made up the difference.
- WAIA is currently \$9,920 in the black, a \$25,000 improvement from the budget assumption and better than our year end assumption.
