- We ended 2020 with an overage of \$16,592. Contributions exceeded the budget by \$24,322, only \$4,634 under our planned income and expenses were reduced by over \$25,000.
- This will cover the current planned overage in the 2021 budget if needed.
- The Finance committee drafted a memo and presented options for the prudent reserve to the Executive committee. We plan to bring a motion to the board at the February board meeting but anyone interested in helping craft that recommendation is welcome to join our Finance Committee next Sunday January 17th at 1pm.
