- Do they wish to stay for the meeting.
- Assist with finding meetings that are ASL Interpreted
- Invite them to stay or contact WAIA or Accessibilty Committee for an available interpretor.

If someone in wheelchair, walker, cane, crutches enters a meeting?

- Meet them at door and welcome.
- Clear a space
- Invite to stay for meeting if possible.
- Assist with obtaining meeting info for their need
- Contact WAIA or Accessibility Committee.

Parliamentary procedures- the Rules Committee will be looking at ways to help everyone familiarize themselves with the bylaws so we're not just counting on one person. There was some discussion about bylaws violations during meetings, there are some things we can clean up, for example making sure someone on Ex Comm is on a corporate committee, etc. so we will be looking at violations and doing a corrective action plan. We will also be looking at meeting procedures, what version of Robert's rules we use, etc. This will include Karen O and David H, and there is a call for service for anyone to join.

Technology: tech@aa-dc.org

The technology committee had a lot of discussion about shifting how meetings are presented so it's easier to find in person meetings that are active versus those that are temporarily closed. The plugin that WAIA uses is one that's sort of nationally available. There are updates that happen that are outside of WAIA's control, so we did something ourselves to give an in-person meeting "type". The plugin has caught up with that technology so now it does things we originally asked for like only listing active meetings. However, the location is disappearing from the list. For example "Came to believe" at Grace Church, it would only say the meeting name and remove location. Therefore WAIA is not going with the plugin for now. Also the plugin puts every group as a location, mixes up location and group. We will make updates visible before upgrading, put through the reopening committee and office committee to troubleshoot, before going with the upgrade.

The tech committee chair announced that he's leaving the area and needs to step down as technology chair. He wants to make a concerted effort to find someone. Mid-September/early October he will leave, so September will be the last board meeting that the current technology chair will be present.

A member noted that the bylaws say a member of the Executive Committee needs to be on the tech committee. You should be a representative, executive committee member, or past chair to be head of a corporate committee.
