



Grace phoned her doctor and he came over and said 'You're in a bad way" and I said I was but I would be alright tomorrow and he said 'No you won't.' I would be going to the County Asylum, the Craig Ainalm Hospital, which is a mental hospital, and I didn't like that but I went there and they were all in their white coats when I arrived. There was this guy there, Jimmy, The Piper, who I knew, and I said to him 'Good God, have you been locked up?' and he said 'No, no. I am here to see you!' He was with David and David was wearing plus fours. I found these plus fours very funny. David was an auctioneer and Jimmy and David said they were there to help me. They would come to the hospital meeting, which was held on Wednesdays. At that meeting there were only four people there. Three of us and a lady called Catherine. I went to that first meeting in pajamas and a dressing gown. I re-



ally didn't know where I was going or what I was doing but they were kind of folk and they knew my problem. I got hope from listening to David and Jimmy sharing. These two became my sponsors and remained my dear friends until they both passed away.

The first convention I went to was in Dunblane Hydro Hotel and I went there for many years. Dunblane was the top convention in Scotland which started in 1957. Then I started to go to as many conventions as I could. It was a great joy to me when I went on to the Board of A.A. I went to all kinds of A.A. events.

I went to my first World Convention in Toronto in 1965 and that's when I shook Bill W's hand. My friend Jack told me I had to go up on the platform with the rest of the Board. I had to walk down through all of these people and Bill spoke to me and put his hand on my shoulder and said, 'My name is Bill and I'm an alcoholic.' and he asked me, 'Colin, Will you pass it on to Scotland?' I took the 'I am Responsible' oath for Scotland with Bill W. then. That memory keeps coming back to me all the time.

A Full Heart

Tonight he left the hospital concerned, exhausted and grief-stricken. But most of all, he felt joy.

One evening a while back, A sponsee of mine relapsed. In spite of all his efforts, he was unable to stay sober. As things worsened and he was going in and out of consciousness, his family took him to the emergency room. Once he was medically stable, he was admitted into the hospital to detox.



Unfortunately, I was unable to be there with him and his family because my grandfather had passed away the day before and I had to leave town. I kept my sponsor and other group members informed as my sponsee's situation changed.

When I was heading back to town, my sponsor and I made plans to visit my sponsee. It was his third day of detox. My sponsor also mentioned that several group members might join us. As we would be visiting him late on a Sunday evening, I didn't anticipate many members showing up.

The weekend had been long and difficult, especially after burying my last grandparent. After I got back, I dropped my wife at home and drove to the hospital. On the way there, I was overcome with deep gratitude for the opportunity to see my friend. My Grandpa had lived a full life of 91 years and undoubtedly touched more lives than just mine. And it made me think that as members of A.A., we have been given the gift of sharing our experience and having the ability to touch life after life.

I pulled into the hospital, parked and walked into the waiting room. As I turned the corner, to my surprise I was met by 11—11!—of my fellow home group members. I was speechless. We all rode the elevator up, and after getting a few suspicious looks from the staff we were allowed in. A staff person told us that no patient had ever received so many visitors at once.

Our beaten-up friend was sitting alone at the back of the room. When he saw me round the corner, he stood up to greet me. Then the rest of our group began to enter and our friend was was overcome with emotion. Speechless, he wept on my shoulder. Each home group member then began to share the hopelessness and suffering they endured, but also the unending peace and joy they've been given through A.A.

The power of the Fellowship in the room that night consumed each one of us. We were able to be instruments of our loving God, offering the hand that we were once offered ourselves. The experience was incredibly moving. I had a cry ball in my throat and had to fight back tears.

I walked out of the hospital alone because I stayed a bit longer than everyone else. As the cold night air hit my face, my tears began to flow. My heart was full that night. Even though I had laid my grandfather to rest that morning, by evening, I had participated in a rebirth.

A.A. Group Inventory for the COVID-19 Era

Many groups periodically hold a "group inventory meeting" to evaluate how well they are fulfilling their primary purpose to help alcoholics recover through A.A.'s suggested Twelve Steps of recovery.

In the COVID-`19 era, many groups quickly transitioned to virtual (online) meetings and may now wish to step back and evaluate how they're doing. Groups that have not returned to any form of in person meeting may need an inventory to reflect their current situation.

Here, the San Jose, CA offers a set of group inventory questions adapted to the COVID-19 era. (Based, in part, on questions in "The A.A. Group" pamphlet.)

Here are some suggested questions that your group could ask itself:

- 1. What is the basic purpose of our group?
- 2. How well is our group carrying the message to the still suffering alcoholic?
- 3. How well is our group serving members who were present before the pandemic? Who has been 'left behind'?
- 4. Have we reached out to help members who are not 'tech savvy' get connected? Is a phone or an e-mail contact list available to members?
- 5. Is our group attracting alcoholics from different backgrounds? Are we seeing a good cross-section of our community, including those with accessibility issues? What kind of alcoholics are we not seeing at our meeting?
- 6. Are we getting many visitors from outside our area? How are we welcoming them to our group?
- 7. Do we effectively emphasize and facilitate sponsorship in the virtual environment? How can we do better?
- 8. Since going virtual, how have out group chores/responsibilities changed? Have we let any important functions go unfulfilled?
- 9. Do we need to modify our group's format to better suit meeting virtually? Who or why not?
- 10. How are we conducting our virtual elections for service positions? Despite being virtual, are we still practicing the spirit of rotation?
- 11. What measures are we taking to ensure safety in our meetings, both against trolls/bombers and with respect to existing members?
- 12. Are we recording our meeting? Why or why not? If so, what precautions are we taking to ensure anonymity?
- 13. Is our group continuing to do its fair share toward participating in our Three Legacies Recovery, Unity, and Service?
- 14. How is our group fulfilling its responsibility to the Seventh Tradition? Are we meeting our expenses and maintaining a prudent reserve? Are we providing both digital and non-digital ways to contribute? Why or why not?

From Box 459: "A.A. at Its Best" New Approaches to the Seventh Tradition

In mid-March of this year (2020), at the onset of the Coronavirus pandemic, the lights went dark at the General Service Office as G.S.O.'s workforce dispersed to their homes to continue helping members carry the message of Alcoholics Anonymous. As the days went on, A.A.'s many central offices strove to remain open to fulfill their essential function, and A.A. groups turned to virtual platforms to ensure that alcoholics everywhere could meet and stay sober. Over the last number of months, a situation without precedent in the lifetime of A.A. has been faced with fortitude, hard work and creativity.

"The amazing thing," says Leslie Backus, Class A (nonalcoholic) treasurer of the General Service Board, pictured nearby, "is that whether the local, the area, or the intergroup level, A.A.'s have found a way to continue carrying the message. Our primary purpose is going strong. It is an awesome and humbling thing to watch."

Suffering alcoholics have been turning to A.A. for 85 years, and the need for Alcoholics Anonymous has never been greater. Despite the physical separation of its employees, G.S.O. General Manager Greg T. wrote in a June (2020) letter to the Fellowship, "G.S.O. in New York is continuing to support all levels of service. Literature still needs to be published and distributed, calls need to be answered, online platforms still need to be updated, and support operations sustained."

At the same time, according to G.S.O. acting Chief Financial Officer Bob W., there were challenges: "In the immediate aftermath of COVID-19, a G.S.O. experienced a sharp decline in contributions and literature sales." The precipitous fall in both of these funding levels – because people could neither contribute in the same way at meetings nor buy books from the group's literature table or at their local intergroup office – forced A.A. to take a \$3 million drawdown from its Reserve Fund at the end of April (2020).

Fortunately, since then, there has been a dramatic increase in contributions from A.A. groups and members, culminating in \$1.1 million for



the month of July (2020) – an extraordinary response. Leslie Backus, who reported on A.A.'s financial situation at A.A.'s virtual 70th General Service Conference and who was also featured in a video released to the Fellowship entitled "Covid-19 & the Seventh Tradition" (https://vimeo.com/430834698), says of the response from Fellowship, "It was the spiritual nature of the Seventh Tradition in Practice, one person stepping up to help other members over and over."

Bob w. adds, "More than the actual dollars themselves, it is about participation, and that is what gets me emotional. That principle of participation is rooted in our Fourth Concept and the Seventh Tradition. Money and spirituality mix in the basket."

Literature sales, meanwhile, have risen only slightly from April, according to Bob, and are nowhere near their average monthly sales levels pre-pandemic. And while some of the \$1.1 million in contributions came from groups, many others were made by individuals via a.a..org (https://contributions.aa.org). Greg T. considers this a sign of unprecedented times, when "individuals perhaps feel a level of responsibility in a different way, under the circumstances."

As many in A.A. know, however, even in the best of times, only 40 percent of groups send a portion of their Seventh Tradition basket to help support the General Service Office. This is nothing new. Bill W. made note of it in a 1966 letter to the Fellowship in which he stated, "We cannot depend on A.A. book and pamphlet income year after year to make up for lack of Group contributions." But the situation we are currently in is new – a global pandemic, an age of transformative technology – and finding solutions to the lack of group contributions that Bill refers to is a conversation that presents itself with some urgency.


