#### Notes:

- Year-to-date sales of literature and chips inventory is slightly higher than budgeted, and substantially higher than last year, continuing a gradual trend toward pre-pandemic sales volumes.
- Gala ticket sales are substantially less than budgeted. As of April 10, ticket sales are at about \$7,000 versus the \$16,000 budgeted to meet initial expense estimates. *Please be sure your groups are aware of the Gala date, and encourage ticket purchases!*
- Cost of Goods Sold in March reflects large advance purchase of literature, ahead of a price
  increase that took effect in early April. Full year Cost of Goods Sold is still expected to be within
  budget.
- Expenses are below budget, primarily due to timing and level of Gala expense.
