Notes:

- Sales of literature and chips were up in November and continue to exceed the annual budget. Sales are higher than last year, continuing a gradual trend toward pre-pandemic sales volumes.
- Cost of Goods Sold reflects large advance purchase of literature in March. Full year Cost of Goods Sold will
 exceed budget, in keeping with higher than budgeted sales.
- Contributions from groups and individuals were up in November, but about \$5000 down from budget and November 2022. Contributions for the year are short about \$16k of the annual budget for the year. We have not received the full expected donations from the Gratitude boxes. WAIA Representatives are encouraged to use the 7th Tradition language below to remind your home groups of the need for continued support and encourage members to contribute via Venmo to @WAIA-DC and for group treasurers to remember to submit money ASAP to WAIA collected in the Gratitude boxes.
